It is a condition of membership of Glenageary Lawn Tennis Club that the members accept and support the Club Constitution and Bye Laws. These can be found on the club website.

Subscriptions are invoiced in January and are due for payment by February 28th 2020 once invoiced they must be paid in full, regardless of whether a member plays for only the latter part of the subscription year.

## Calculating the entrance fee and subscription fee

### Family membership

Family Members are members belonging to the same family, consisting of at least one Senior Member, and living in the same family home. Children of such families cannot be members until the January following their 5<sup>th</sup> birthday. The family subscription is the same regardless of the number of members in the family.

### Family discount where members join as individuals

Three or more playing members of the same family, residing at the same address is entitled to a discount of 20% on the ANNUAL SUBSCRIPTION. This discount does NOT apply to “Family Membership”. The following discounts apply to the ENTRANCE FEE for individual members of the same family:

| 3 <sup>rd</sup> family member                     | 50% discount off 3 <sup>rd</sup> entrance fee     |
| 4 <sup>th</sup> family member                     | 75% discount off 4 <sup>th</sup> entrance fee     |
| 5 <sup>th</sup> and subsequent                    | NO FEE for 5 <sup>th</sup> and subsequent members |

**Example:** 1 adult plus 2 children

Subscription = (€385 + €245 + €245) – 20% = €700.00

Entrance = €95 x 2 + €260 - 50% = €320.00

Total = €1020.00

### Joining mid-year

New members joining mid-year must pay the full entrance fee applicable but may avail of a reduction on the subscription fee until the end of the year. The subscription due is equivalent to 10% per month for the remaining months in the year, the first month being the month in which the new member joins. IMPORTANT: The subscription falls due in January every year, regardless of the joining month.

**Example:** Family joins in August. There are 5 months remaining in the year.

Subscription = €795 x 10% x 5 (months remaining) = €397.50

Entrance = €355

Total = €752.50
